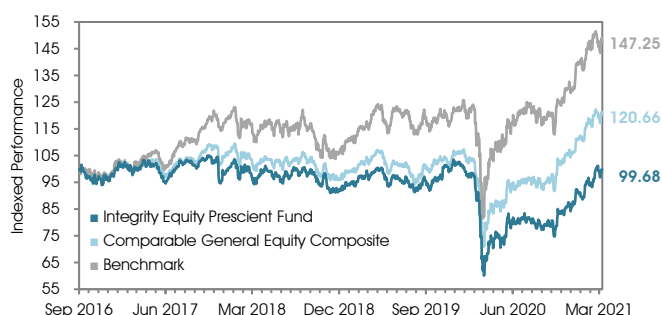

## Portfolio Description

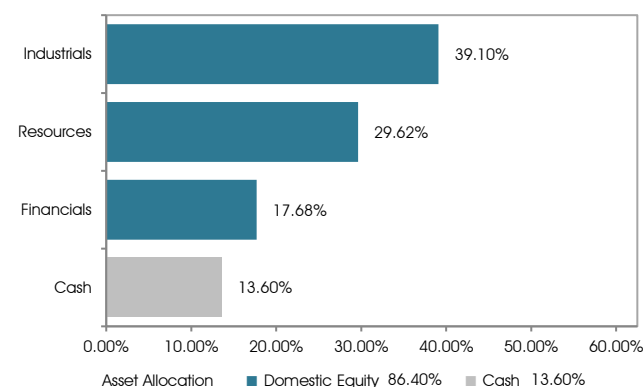
The primary objective of the portfolio is to achieve long term capital appreciation by investing in a diversified portfolio of **South African listed equities**. The portfolio manager acquires local equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of worldwide economic, sector and investment trends to tilt the portfolio towards attractive sectors and companies.

The Integrity Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a **value investment philosophy and process**. This is the same investment philosophy and process applied in managing the Integrity Local Equity Strategy, with track record since 5 August 2011.

The portfolio has adhered to its policy objective since its inception.

## Relative performance

Over the quarter, the fund returned 14.80% compared to the FTSE/JSE All Share Index's return of 13.14%. Resources led the charge, with Sasol and Anglo American contributing 2.96% and 1.27% respectively. Exposure to Trellidor and MTN further bolstered outperformance, contributing 2.40% and 1.37% respectively. Over the quarter, a continued tilt from growth to value was experienced, as the FTSE/JSE Growth Index increased by 11.3% compared to the increase of 13.9% in the FTSE/JSE Value Index. The Investment Manager expects this outperformance to persist and expand in the future.

## Fund composition

During the period, both Mondi and BHP Billiton reached estimates of fair value and were sold. This resulted in the fund's Resources sector allocation decreasing from 37.12% to 29.62%. The same can be said for The Foschini Group, which has benefited from the return of optimism in operating trading conditions. The increase in market levels over the quarter decreased its discount to fair value, resulting in its disposal. The proceeds of these sales have been kept in cash. The Investment Manager wished to maintain the somewhat elevated cash holding until sufficiently undervalued opportunities arise.
