## Portfolio Description

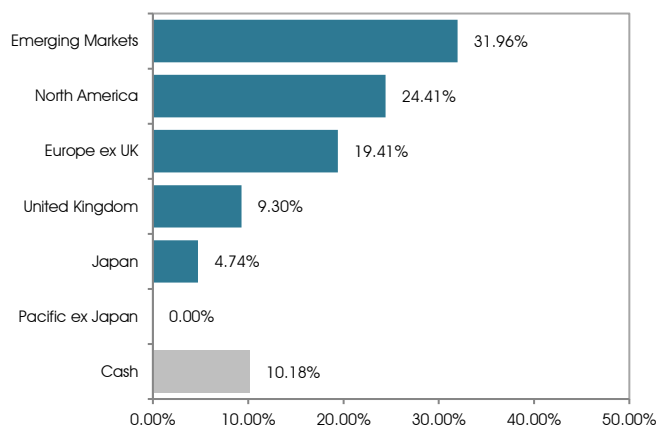
Integrity diligently follows a **value investment philosophy and process**.

A minimum of 80% of the portfolio will be invested in equities and the portfolio is therefore suitable for investors with an investment horizon of five years or longer.

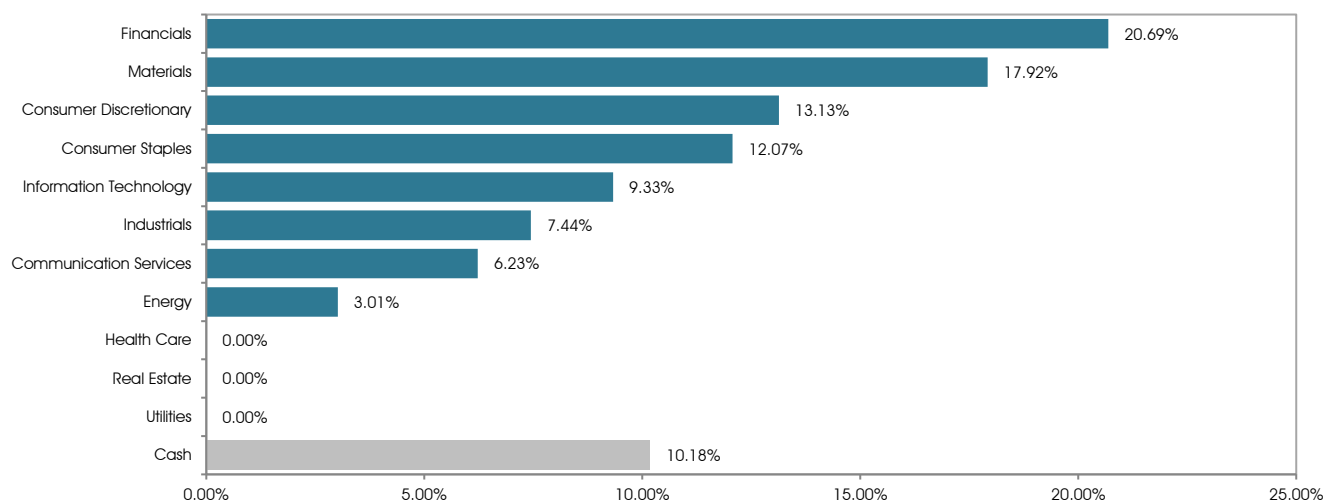
